

ATMC BOARD ELECTS NEW OFFICERS, APPOINTS NEW DIRECTOR

The Board of Directors of ATMC has announced the election of a new Board President and Vice President as well as the appointment of a new member to the Board. The changes occurred as a result of the recent death of long-time board member and President, Lyle Ray King.

Douglas H. Hawes, ATMC Director representing District 6, was elected President. Mr. Hawes had served as Vice President of the Board since 2012 and has served as a Director for 25 years. James H. Milliken, District 4 Director, was elected to serve as the new Vice President. Mr. Milliken has been on the ATMC Board for 13 years. Gene Ward, District 7, will continue to serve as Secretary/Treasurer.

In addition to the election of new officers, Whitney King has been appointed to the Board to represent District 1. Mr. King is a Brunswick County native, a graduate of the University of North Carolina at Chapel Hill, and a local

businessman. He has served in leadership roles for the Tobacco Growers Association of North Carolina and the Brunswick County Hospital Authority. He currently serves on the board of the Dock Street Homeowners Association. Mr. King and his wife, Suzanne, live in Ash.

Douglas Hawes said that Mr. King is a welcome addition to the ATMC Board. He added, "Mr. King's roots in our community and his experience as a local business owner will make him a great asset to our board and this cooperative. We look forward to working with him."


